

1. Reservation:

Upon your signature, Sweet-P Family Photography will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation Deposit of 10% is non-refundable, even if the date is changed or the wedding cancelled for any reason; including acts of nature or illness. The Reservation Deposit is to be paid at time of signing the contract. The Reservation Deposit is applied towards the contracted wedding photography package. THE CLIENT understands and agrees that the entire amount owed for the wedding photography package described in the contract is due on the day of the wedding or the delivery of the CD.

2. Indemnification:

Bride and Groom shall indemnify and hold harmless the Photographer from any loss, damage or liability resulting from Bride & Groom's violation of the terms of this Agreement or any agreement involving the Bride & Groom and the Photographer. The Bride & Groom shall indemnify the Photographer and hold him harmless from and against any claim by any other person or entity resulting from the performance of his services under this agreement. The Bride & Groom shall indemnify the Photographer and hold him harmless from, for, and against any destruction of data including but not limited to fire, theft, and corruption.

3. Assignability and Parties of Interest:

Except as otherwise provided herein, the terms and conditions of this Agreement shall inure to the benefit of and be binding upon the respective successors and assigns of the parties. Nothing in this Agreement, express or implied, will confer upon any person or entity not a party to this Agreement, or the legal representatives of such person or entity, any rights, remedies, obligations, or liabilities of any nature or kind whatsoever under or by reason of this Agreement, except as expressly provided in this Agreement.

4. Independent Contractors:

In providing services pursuant to this Agreement, the Parties shall be independent contractors, and no party to this Agreement shall make any representations or statements indicating or suggesting that any joint venture, partnership, or other such relationship exists between any of the parties except as set forth herein.

5. Entire Agreement:

This Agreement constitutes a single integrated contract expressing the entire agreement of Bride and Groom and Photographer with respect to the subject matter hereof and supersedes all prior and contemporaneous oral and written agreements and discussions with respect to the subject matter hereof, and, except as specifically set forth herein, there are no other agreements, representations, promises or inducements, written or oral, express or implied, between the parties hereto with respect to the subject matter hereof.

6. Amendment and Waiver:

This Agreement and each provision hereof may be amended, modified, supplemented or waived only by a written document specifically identifying this Agreement and duly executed by each party hereto or the authorized representative of such party. Except as expressly provided in this Agreement, no course of dealing between the parties hereto and no delay in exercising any right, power or remedy conferred hereby or now or hereafter existing at law, in equity, by statute or otherwise, shall operate as a waiver of, or otherwise prejudice, any such rights, power or remedy.

7. Counterparts:

This Agreement may be executed in counterparts. The execution of a signature page of this Agreement shall constitute the execution of the Agreement, and the Agreement shall be binding on each party upon the date of signature, if each party executes such counterpart.

8. Severability: If any part of this Agreement is determined to be void, invalid, inoperative or unenforceable by a court of competent jurisdiction or by any other legally constituted body

having jurisdiction to make such determination, such decision shall not affect any other provisions hereof and the remainder of this Agreement shall be effective as though such void, invalid, inoperative or unenforceable provision had not been contained herein.

9. Copyright

The Photographer will retain copyright of all pictures from the shoot in recognition of his work as photographer. This will not be used to prevent the Bride & Groom distributing the files for non-commercial purposes.

10. Photo Release and Distribution

Photographs from the wedding day may be used by the Bride and Groom for any non-commercial purposes. The Bride & Groom may make unlimited copies of the photographs including copies of the DVD and the files it contains. These copies may be distributed freely for non-commercial purposes.

The Bride & Groom agree to release all photographs to the photographer for the purposes of advertising; this includes the use of the photographs in a portfolio and publication of images in print, on Sweet-P Family Photography's website and facebook site, or on other websites.

11. Illness, injury, and/or death:

In the event of illness and/or injury and/or death of the photographer or an associate of the photographer (including but not limited to the photographer's friends and family) preventing the photographer from fulfilling his role under this contract a full refund will be given and the photographer will aid the bride and groom in finding a replacement photographer if possible. The bride and groom acknowledge and accept that the photographer will be the judge of whether or not such illness, injury, or death is severe enough to prevent her from fulfilling her role under the contract.
